This contract is between the parent(s)/guardians listed below and Magic Apple School. It is valid from the date below and remains effective until the student is no longer enrolled.

**Tuition:** The Fall program is charged on a monthly basis based on a 10-month school term from August (tuition includes June of the following year) and is not adjusted for illness, vacation, holidays or absences of any nature. All tuition is due by the first of the month and late after the 10<sup>th</sup> unless payment arrangements have been made. Late fees are charged at \$20, returned checks at \$30. Notice to terminate enrollment may be given by either parent or school, however, both parties agree to provide a written notice of at least one-month (*note: prepaid tuition for June of the following year may NOT be applied to outstanding tuition nor is it refundable with early withdrawals*). Magic Apple Summer Camps are charged on a weekly basis and are not adjust for illness, vacation, holidays or absences of any nature. Notice to terminate enrollment may be given by either parent or school, however both parties agree to provide a written notice of at least one-week for summer daycamp attendance.

During the student's first two weeks of attendance in the afterschool program written notice may be given by Magic Apple staff and/or parents should it be determined that continued enrollment is not in the best interest of the child *for any reason*. After this initial 2-week parents and school agree to provide written notice of at least 30 days and all terms of enrollment will apply as described above.

Parents agree to contact Magic Apple whenever their child will not be attending as scheduled. Parents of Rio Del Mar elementary also understand that students not making it in time to the Magic Apple bus will return to the Rio Del Mar office to contact their family. Parents agree that it is the family's responsibility to arrange for pick up if child does not arrive at the bus. All families agree to be on time at the end of the day (5:30) and understand that student not met at Deer Park by 5:35 will return to Magic apple **as an emergency service only** and late fees of \$10 for 15 minutes may apply.

Insurance Waiver: In signing below parents give permission for the faculty and staff of Magic Apple School to accept and allow \_\_\_\_\_ on the date indicated below to attend Magic Apple School and or Camp Western Town and agree to hold harmless and free of any and all liability Francisco and Janice Jimenez and any Magic Apple staff, assistants, volunteers and employees in general for any acts of negligence and/or possible injury to \_\_\_\_\_ while in attendance at Magic Apple as well on any school outings, walks, field trips, activities, etc. This hold harmless agreement and release of all claims is entered into freely and voluntarily for the consideration set forth above which is in addition to and independent of any other consideration agreed upon by those entering into this agreement.
